DEATH PENALTY FACTS

Over 3,000 individuals await execution on America's death row.



For every 9 executions, one person on death row has been exonerated.

RACE

Roughly 80% of death penalty cases resulting in an execution involved a white victim, even though only 50% of all murder victims are white.

PLACE 56% of US death sentences come form 2% of counties



POVERTY

Nearly all death penalty defendants cannot afford to hire a private attorney.

MENTAL ILLNESS

Over half of the last 100 people executed were diagnosed with or displayed symptoms of mental illness.



REFLECTION QUESTIONS

Do I embrace the call to mercy and encounter in my relations with loved ones and with my community?

As I practice prayer, fasting, and almsgiving this Lent, am I reflecting on survivors and families whose lives have been touched by crime? Are incarcerated persons and their families also present in my reflections?

Is my parish a welcoming place, an 'oasis of mercy,' for those whose lives have been harmed by crime? For those who are incarcerated, formerly incarcerated, or family members of the incarcerated?

As I reflect upon the execution of our savior Jesus Christ, how am I called to oppose the executions of all of the children of God?

Do I strive to live the principles of being unconditionally pro-life? How do I work on a daily basis to build a culture of life?
